Party A (Music Hall Management): Bylinghua Music Hall

In order to ensure the safety of the music hall's use, Party B agrees to the following terms for using the music hall and assumes all risks that may occur during the use.

1. Insurance Requirement

Party B is strongly encouraged to purchase relevant insurance to cover any accidents or incidents that may occur during the use of the music hall. Party B may choose an appropriate insurance company and policy; however, Bylinghua Music Hall does not provide any insurance services.

2. Waiver Clause

If Party B chooses not to purchase insurance, Party B must sign this agreement and agree to the following terms:

1. Should any accidents, injuries, or property damage occur during the use of the music hall (whether involving Party B or third parties), Party B agrees to bear full responsibility for all liabilities, and will not make any claims, lawsuits, or other demands against Party A.
2. Party B acknowledges and understands the potential risks of using the music hall without insurance and agrees to bear all consequences arising from personal negligence, accidents, natural disasters, or other events.
3. Party B agrees not to hold Bylinghua Music Hall responsible for any compensation, fees, or legal liabilities related to the use of the music hall.

3. Agreement Effectiveness

This agreement takes effect upon Party B's signature and remains in effect throughout the duration of Party B's use of the music hall. Party B confirms that they have fully understood and agreed to the above terms and promises to comply with them.
